Here are some highlights of this incredible work:

- Sunny Akani of Advocates Africa, is at present advocating for more than 40 persecuted Christians in Nigeria.
- Board member Tehmina Arora and her team in Asia are actively working to defend individuals affected by anti-conversion laws, forced marriage, and forced conversions. Recently, they helped Reeha, a 16-year-old from Pakistan who had been kidnapped, win her legal battle, leading to her freedom from forced conversion and forced marriage!
- In Egypt, our brother Emad Felix is representing Abdulbaqi Saeed, a Yemeni Christian arrested and charged for committing blasphemy. He has been held for two and a half years without trial!
- Latcho Popov and the Bulgarian Rule of Law Institute recently celebrated 30 years of fighting for justice in Bulgaria, where they have achieved much success fighting for religious freedom, family rights, pro-life and integrity under the rule of law.
- In Ethiopia, Advocates Ethiopia has been teaching churches how to advocate for religious freedom and combat religious persecution.

- Selvi Ganesh, from Chennai, India, uses her legal training to support widows who are left to fend for themselves. She has been lecturing visiting US professors and students on crimes against

women in India.

- Abishag Samba, a young lawyer from Northern Nigeria, and her team work tirelessly to free Christian women and young girls forced into marriages with much older Muslim men. Many of these girls, some as young as 10-15, face serious health challenges due to these marriages.
- A former Muslim who has been preaching Christianity in rural Central Nigeria, was arrested in February 2024 on false charges of conspiracy and murder. Members of the AI team quickly secured his release on bail. They are now representing him in his legal case.
- Through the efforts of our advocates, Rev. Jonah Gangas and his wife Josephine were released from prison in Nigeria in March 2024. They were held on fabricated charges of kidnapping and converting the 12-year-old Sadiya Idris to Christianity. All charges were dismissed.

What a blessing it is to serve with these incredible leaders! We praise the Lord for His goodness to us by allowing us to serve Him in this manner. I am so humbled to serve alongside those serving on the ground to make sure all hear of His love.
